As per reference 1stcited, approval was granted to the Principal. Dr. Moopen's Nursing College, Naseera Nagar, Meppadi, Wayanad to admit students to the BSc Nursing Programme during the academic year 2024-25. The Principal. Dr. Moopen's Nursing College, Naseera Nagar, Meppadi, Wayanad vide his letter read (2) above has submitted the application for continuation of affiliation to conduct the BSc Nursing course for the academic year 2025-26.

Based on the application an inspection team consisting of qualified faculty members conducted inspection at the institution and has submitted a report. The inspection report was scrutinized by the scrutiny committee and is pending approval of the council. Now vide letter read (3) above, Government has directed to issue Conditional Affiliation to Nursing Colleges whose inspection has been completed.

As per the reference 4th cited, the principal submitted the Compliance report
In the above circumstances, sanction is hereby accorded to grant conditional
affiliation to the *Principal*, *Dr. Moopen's Nursing College*, *Naseera Nagar*,

Meppadi, Wayanad for conducting BSc Nursing programme with an intake of 85
Students for the academic year 2025-26 subject to the following conditions.

- 1. Teacher student ratio should be maintained.
- 2. Academic & Administrative matters shall be made only on the basis of the rules and regulations of the University / Government and on the basis of the directions issued by the Kerala Nurses and Midwives Council from time to time, failing which the conditional affiliation granted will be withdrawn.
- 3. Inspection fee for the year 2025-26 should be remitted.
- 4. Admission should only be made to seats sanctioned by INC/KNMC/KUHS.If the number of intake is reduced either by Kerala University of Health Sciences or Indian Nursing Council, the number of seats to which admission can be made should be reduced accordingly.
- 5. The management is required to adhere strictly to the guidelines issued by the Government, the Indian Nursing Council and the Kerala Nurses and Midwives Council for conducting the Programme.
- 6. The Management should obtain affiliation from the Kerala University of Health Sciences, Thrissur and suitability from Indian Nursing Council before admitting the students.
- 7. The Management should obtain separate order from the Kerala Nurses and Midwives Council to admit the next batch of student for the academic year 2026-27.
- 8. The admission should strictly be in accordance with the Seat Matrix issued by Government of Kerala for the year 2025-26, failing of which, the conditional affiliation granted will be withdrawn.
- 9. Deficiencies if any intimated from Kerala Nurses and Midwives Council found in due course during the academic year 2025-26 should be rectified and rectification report submitted to this office within a period of one month.
