- Dr. Moopen's Nursing College admits students under Management Quota/ NRI and the seats available are limited to 43 numbers, the remaining seats will be allotted by Govt.
- This prospectus contains the rules and regulations applicable for selection and admission to BSc Nursing seats to be filled by the Management for the academic year 2025-2026. Candidates are requested to go through the Prospectus carefully and familiarize themselves with all relevant information. They are also encouraged to visit the official website of the colleges, "drmoopensnc.ac.in" for more details.
- The conditions in this prospectus are subject to modification/addition/deletion, as may be deemed necessary by the Management/ admission approval committee.
- Admission is made subject to the Orders of the Hon'ble Courts, Indian Nursing Council, KNMC and Admission Supervisory and fee Regulating Committee for the professional colleges in Kerala and Kerala University of Health Sciences.

1. CRITERIA OF ELIGIBILITY FOR ADMISSION

1.1 Academic

I. Candidates who have passed Higher Secondary Examination conducted by the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by the Universities in the State of Kerala with aggregate of 50% marks in Physics,

Chemistry, Biology and 50% marks in English in second Year only are eligible for admission.

II. Relaxation in Marks

a) Candidates belonging to SEBC (Socially and Educationally Backward Classes) in the State of Kerala with total annual family income up to Rs.6 lakhs will have relaxation of 5% marks. The Scheduled Caste and Scheduled Tribe candidates in the state of Kerala need only a pass in the qualifying examination

b) Those candidates claiming relaxation of marks shall produce necessary Certificates from the authority concerned. There will be no reservation of seats for SEBC and or SC/ST candidates under Management quota.

III. Eligibility Certificates: Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

1.2 Age

(i) Applicants should have completed 17 years of age on the 31st December 2025. No relaxation of the minimum age will be allowed.

(ii) Self-attested copy of relevant page of school record namely SSLC/ICSE/CBSE/ certificate showing the date of birth / copy of birth certificate should be produced at the time of admission.

2. HOW TO APPLY

a. Application for admission to B.Sc. Nursing course can be submitted/registered only online mode. The online application is available with website “www.drmoopensnc.ac.in”

b. Submission of Application

- Application form can be submitted ONLINE only. The application form along with copies of uploaded documents need to be dispatched to the office after completion of online application submission.
- Before applying online, candidates should have:
- A valid email ID (if you do not have an email address, we recommend Gmail ID) Scanned copy of recent passport size color photograph (taken after 1st January 2025). Photograph should be taken in a white/light colored background. The image should be in JPEG format. Maximum size of photograph 50 KB and image dimension is 120 x 150 px (4.23 x 5.29cm)
- Scanned copy of student signature on the application.
- Scanned copy of the certificates. The image should be in JPEG / PDF format. Maximum size for JPEG / PDF files 500 KB.
 1. Secondary School Leaving Certificate (SSLC)
 2. Plus Two Mark List
 3. TC, Course and Conduct Certificate
 4. Adhaar Card
- The attached/ uploaded documents should be legible (Illegible documents may lead to rejection of application).
- The details of Application Fee Payments
 1. B.Sc. Nursing: Rs. 1000/- (One thousand only)
 2. The application fee can be paid through Internet Banking Debit / Credit Cards to the college Account or as DD (Demand draft). Payment reference Number to be filled in the application
- The following original documents have to be submitted at the time of admission.
- Secondary School Leaving Certificate (SSLC) or equivalent certificate to prove age, date of birth and place of birth.
- Certificate and Mark list of SSLC / 10th Std.
- Certificate and Mark list of qualifying Examination (Plus Two / 12th Std.)
- Transfer Certificate (T.C)
- Course & Conduct Certificate.
- Migration Certificate, if applicable.
- Undertaking properly signed as per annexure II of the prospectus regarding non- involvement in ragging.

- Copy of Photo Id Proof (Aadhaar / Voters ID / Passport)
- Copy of the online application form.
- CD containing scanned copy of all these documents and photo.
- Every candidate before admission to the course shall submit to the Principal of the Institution, a certificate of Medical Fitness from an authorized Medical Officer with MBBS or higher qualification certifying that the candidate is fit to undergo the course. (Annexure 1)
- Date of Birth & Name printed Photograph Passport size 8 (No's).
- Equivalence certificate from Association of Indian Universities (if applicable).
- Eligibility certificate from Kerala University of Health Sciences (if applicable).
- Two sets of self-attested photocopies of all the above certificates/documents have to be submitted at the time admission.
- The original documents shall be submitted at the time of admission.
- **NRI candidates should submit separate application with copies of following documents.**
 1. Declaration of the Sponsor.
 2. Relationship Certificate issued by the competent authority.
 3. Valid Passport copy of the sponsor with Embassy Attestation.
 4. Visa copy of the sponsor with Embassy Attestation.
 5. Employment certificate of the sponsor.
 6. Other supporting documents.

c. Availability of Prospectus

- ii. **SELECTION:** Selection of candidates will be based on merit list prepared on the basis of the marks obtained in the qualifying examination.

3. PREPARATION OF MERIT LIST

3.1 Merit list

(b) Management seats will be filled from the applications received on the basis of merit. The merit list will be prepared on the basis of marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria.

1. Rank list will be prepared on the basis of mark (Plus two- Science + English).
2. If there is any tie in marks, the total plus two marks will be considered.
3. Upload the Provisional rank list on the basis of above criteria.

(c) 15% NRI seats shall be filled up from qualified students as per G.O (MS) No.2014/243/HRFWD dated 6.08.2014 of Govt. of Kerala.

3.2. Resolution of tie while ranking:

In the case of a tie in the total marks, the marks in Biology will be counted. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.

3.3. Validity of the merit list

The published merit list will be valid till the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.

3.4. Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the criteria regarding the eligibility for admission and other conditions as laid down in the Prospectus.

3.5. Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

IMPORTANT:

1. The tentative schedule of admission is available on website.
2. Candidates are advised to visit website for all notifications / information and also to get updated on any change or modification in admission schedule, No personal intimation will be sent in this regard.
3. Candidate who do not take admission on the prescribed date will lose their admission.
4. **Admission & Payment of Fees**
 - 4.1 The selected candidates will be informed through registered mobile number and the candidate select list will be published in the website.
 - 4.2 The students shall pay all fees of the 1st year of the course at the time of admission.

Discontinuation:

If any candidate discontinues the course, after the cut-off date as notified by the authority, the candidate has to pay the tuition fee for the remaining years. The Collection of liquidated damages shall be as per the final decision of the Court of Law.

Examination:

End of each Semester there will be regular university examinations. Candidates should pay the examination fees as stipulated by university from time to time.

Eligibility for Appearing Examination

University examinations are typically held twice a year. Candidates who have completed the prescribed course of study in accordance with university guidelines are eligible to sit for the examinations. However, no candidate will be permitted to take any part of the examinations unless they have achieved a minimum of 80% attendance in both classes and practicals for each subject individually.

Additionally, candidates who do not attain a minimum class average mark of 50% (internal assessment) will not be allowed to appear for the university examinations in any subject for that particular year of study

RULES AND REGULATIONS

College

1. Working Hours: The class, clinical, and lab hours for students are from 8:00 AM to 4:30 PM.
2. Supervision: Students will be under the supervision and care of the Principal throughout the duration of their course.
3. ID Card: Students must wear their ID cards at all times while on campus.
4. Entry on Holidays: Students are not permitted to enter the hospital or college on holidays without prior permission from the Principal or Hostel authorities.
5. Illness: In case of illness, students must immediately report to the health-in-charge or the warden.
6. Gifts: Students are prohibited from receiving any gifts at any time from hospital patients or their relatives.
7. Misbehavior: Any form of misbehavior towards patients, their relatives, fellow students, or staff members of the institution or hospital will not be tolerated.
8. Ethical Conduct: During training, students are expected to maintain the highest ethical standards. They must adhere to the institution's rules, approach their studies and work with a positive attitude, and perform their duties with care and responsibility.
9. Ragging: Ragging in any form is strictly prohibited on campus. Any student found engaging in ragging will face legal action as per applicable laws. Additionally, the student will be expelled from the college in accordance with the relevant laws and the directions issued by the Honorable Supreme Court of India.
10. Other Directives: Any directives not explicitly covered in this prospectus will be decided by the college authorities as needed.

Uniform

All students should be well dressed while coming to the college and clinical. They should wear the prescribed uniform as per the policy.
